Subject: Constitution of Start-up Policy Monitoring and Review Committee.

Preamble:

In Government Order read at (1) above, Karnataka Start-up Policy-2015-2020 has been announced. The Policy envisages setting up of a Start-up Policy Monitoring and Review Committee under the Chairmanship of Chief Secretary to Government of Karnataka, apart from the Start-up Council under the Chairmanship of Hon'ble Chief Minister. The Government Order cited above states that the Monitoring and Review Committee shall have Principal Secretary-IT, BT and S&T, senior officers of Government, two/three outside experts as members and Managing Director, KBITS as the convener.

1. Review the implementation of various strategies and programmes enumerated in the policy from time to time, and make necessary suggestions for improved implementation.
2. Ensure that detailed operational guideline for the implementation of the policy are in place, and suggest necessary measure to facilitate ease of doing business for the startups.

3. Review the status report on the usefulness of the policy, outcomes achieved, ease of implementation etc and make necessary recommendations to the startup council.
4. Meet at least twice a year, and as frequently as required in order to monitor the implementation of the Start-up Policy.
5. Any other related aspect as deemed fit.
